## SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS OF SOMMER PLACE SUBDIVISION


The undersigned, as Managers of SUMMER PARK, L.L.C., Developer of the said Subdivision, pursuant to Article III, Paragraph 16 of the First Amendment to Declaration of Restrictions of Sommer Place Subdivision, filed January 19, 2007, as Document No. 07-02106, in connection with Sections One, Two and Three of Sommer Place Subdivision (see Exhibit A for lots and property tax identification numbers), does amend said Declaration as follows:

- 1. ARTICLE I, (e) is deleted and replaced by the following:
  - (e) Developer: Summer Park, L.L.C., or its successor or assigns.
- ARTICLE IV, Paragraph 2 is deleted and replaced by the following:
  - 2. <u>FORMATION OF THE ASSOCIATION</u>. The Association shall be formed the earlier of a) the sale of all of the Developer's interest in the Subdivision, or b) the sale of seventy-five percent (75%) of the Lots in Sections One, Two and Three of the Subdivision plus written approval by the Declarant/Developer for formation of the Association. The Association shall be deemed formed when a written notice of the formation of the Association has been recorded in the Office of the Peoria County Recorder of Deeds and indexed to each Lot in the Subdivision.
- The Declaration of Restrictions of Sommer Place Subdivision, as amended, shall remain in full force and effect according to its terms.
- 4. To the extent that there are inconsistencies or conflicts between this Amendment and the Declaration, this Amendment shall control in all respects.
